SECTION 5. FIREFIGHTING MEASURES

Advice on safe handling : Avoid excessive inhalation of concentrated vapors. Follow good manufacturing practices for housekeeping and personal hygiene. b)during short term maintenance procedures when engineering controls are not in normal operation or are not sufficient; or
c)if normal operational workplace vapor concentration in the air is increased due to heat ;
